The ITI Implant Privilege Mastership will be confirmed to proceed not later than 14 days prior to its scheduled starting date.

- If sufficient confirmed registrations have not been received two weeks in advance of the scheduled starting date, the workshop may be cancelled.

- If notice is received 14 or less days from the scheduled starting date, a 50% refund of the total amount you registered will be offered, and
